#### 2024 in Review by LWVAL President Kathy Jones

The League of Women Voters of Alabama and the League of Women Voters of Alabama Education Fund organizations have been very busy creating good trouble in 2024. Just like in past years, the League began the year engaging with the state legislature to advocate for or against priority bills. Our flagship LWV AL Education Fund government transparency project TheAlabamaChannel.org continued another year of providing an invaluable community service by recording and archiving state legislative committee, house, and senate meetings and providing time stamped searchable transcripts. In 2024 we were honored to collaborate with Alabama State University and 6 of their student interns who went into the statehouse to record non-livestreamed committee meetings for TheAlabamaChannel.org.



We testified and advocated against the harsh and voter suppressive absentee voting assistance criminalization bill in the legislature, but unfortunately it passed quickly.

Many other egregious bills were quickly crashed through by the supermajority in the state legislature with little discussion and a deaf

ear to citizen inputs.

The LWV AL and the LWV AL Education Fund were undeterred and joined several other organizational plaintiffs to file a federal lawsuit against SB1. In late September an SB1 injunction was granted that allowed us to assist blind, disabled, or low literacy voters with their absentee ballot applications.


Our unceasing efforts to fight against voter suppression continued with our support of a lawsuit fighting the HB100 law that tripled the number of moral turpitudes to include �attempting to commit a moral turpitude. In violation of the state constitution, HB100 was passed less than 6 months before the general election. The lawsuit was successful in delaying the enactment of the law until November 6.

When the Secretary of State enacted a voter purge of 3200 people he baselessly claimed were noncitizens within the NVRA mandated �quiet period �, the LWV AL and the LWV AL Education Fund again joined as plaintiffs to push back against voter intimidation.



The judge quickly found in democracy s favor and required the SoS to restore them to the voter rolls so they could vote on November 5.

In parallel with fighting for voting rights, the LWV AL Education Fund continued its core mission of voter education and get out the vote activities. The creation of the new congressional district 2 finally allowed Alabama s African American population to have the chance to have proportional representation.



The LWVAL Ed Fund Board of Directors voted to have a get out the vote postcard project to encourage the African Americans in CD2 to make their voices heard on November 5.

Over 37,000 handwritten nonpartisan GOTV postcards were mailed to rural voters in CD2.

Other important LWV AL Education Fund work included sending thousands of voter services flyers and cards to each local league, providing a small grant to support local GOTV efforts, publishing of the Alabama Vote411 voter information website, providing many valuable educational forums on topics that voters care about, and the 7th year of the LWVAL Ed Fund Voter Rights Restoration network providing direct services to disenfranchised voters.

The LWV AL and the LWV AL Education Fund and our members have impacted 10s of 1000s of voters over the last year alone. We are making a significant difference as we work in community with our members, our allies, and with elected leaders.

Additionally, we have a robust online presence. The table shows some metrics on how many members and voters we reached in 2024.

After the November election we have pivoted again to preparing for more good work and good trouble for 2025.

This year the LWV Alabama board identified three priority voting bills that we are going to lobby for: Early Voting, Absentee Ballot Affidavit Curing, and a bill which would allow a person with a disability to designate someone to pick up or turn in an absentee ballot application or absentee ballot package.



The LWV Alabama Advocacy Committee is already reviewing pre-filed bills against the LWV Impact on Issues and State positions. Our newly created LWV Alabama Lobby Corps is preparing for an intensive legislative session.

In January you will receive guidance on how you can help us advocate to get early voting and absentee voting improvements for Alabama. In the coming legislative session we are collaborating with partner organizations to support each other s advocacy. We re having Advocacy Tuesdays to organize and streamline our League advocacy with specific actions you can take to create change in Alabama. Again the LWV Alabama Education Fund will be focused on government transparency with continued expansion and strengthening of TheAlabamaChannel.org, voter education, Vote411, and civic engagement work.

In the coming year be on the look out for volunteer opportunities and activities, relationship building with new and old friends, leadership development, voter education on issues, and community engagement. Being a member of the League of Women Voters is a fun way to make new friends while making a difference for your community!

This free, educational event is sponsored by the League of Women Voters of Alabama (LWVAL) in collaboration with the LWV of Baldwin County and is open to LWV *members* from Alabama, Florida, Mississippi, Louisiana, and Texas. Sister State Leagues in Alabama, Florida, and Louisiana are collaborating to create a powerful convening that brings League members together, builds knowledge, and lays the foundation for the League to tackle the common problems that Gulf Coast communities are facing as the climate is shifting.

- A lunch speaker briefly addresses specific local issues
- Our afternoon is a discussion and solutions session with just us LWV members to prioritize what we can do as individuals, as well as and what we can do as local and state leagues. We want everyone to come away with solid info and solutions and/or actions in hand.

When we adjourn at 3:30, there will be an option for guided tours. More details to come.



# How I Got To the League

Judy Jones

It took me until my 66th year before my path finally intersected with the League of Women Voters.

It was 2020. I watched as states around the country scrambled to figure out voting during a pandemic. Some states seemed to be trying to make it easier. Some seemed to be making it harder. I did not have faith that Alabama, with its 'excuse only' absentee voting, would do the right thing to make it easier and safer for people to vote. For the first time in my life, my 'hair was on fire' about voting and ballot access. And I didn't know what to do about it.

Then one day I was riding about and I noticed a yard sign in front of a friend's house. All my bells went off.



I immediately texted my friend and asked where she got the sign. She replied - it's the League of Women Voters. I went a-googling and found the League of Women Voters of Greater Birmingham and I reached out to then-president Leonette Slay. Leonette talked to me about the current state of absentee voting in Alabama. I was secretary of my neighborhood at the time and asked Leonette if she would come to one of our meetings (being held by zoom ) and explain absentee voting to our residents. She agreed and attended our meeting, which during the pandemic, was being held via zoom.

Of course Leonette and the topic was a great hit. Absentee voting is complicated at best - but in Covid time, it was more complicated because they changed the rules but not the form. I wrote minutes, had conversations with Leonette to confirm what I wrote was accurate. Along the way learned more and more about the League. And a few months later, I joined. Because of a sign in a friend's front yard.

BUT hear me, that 'sign' is not the reason I am in local league and state league leadership. The League got on my radar, at age 66, because of the sign. I serve in leadership because -

- I now KNOW how important the League is, the contribution they make, at holding the line in Alabama on voting rights
- I now KNOW how satisfying it is to work with a group of smart people, who are altruistically donating their time to support voting rights for all Alabamians
- I am learning, serving and having fun!

The League rocks.

PS I now own the sign. My friend loved so much that her sign got me to the League, she gifted it to me.


